Fake Debt Collectors: The Federal Trade Commission has shut down two debt collectors and three companies charging them with false threats and other illegal collection tactics. Your rights are spelled out in the "Fair Debt Collection Practices Act." (Frank Dorman, FTC Office of Public Affairs). Ask the caller for his or her name, company, street address, and telephone number. Tell the person you will not discuss anything with him or her unless you are provided with a "validation notice," which includes the amount of debt, the name of the creditor you owe and your rights under the FDCPA. Write the debt collector a letter (keep a copy) and demand that they stop contacting you. (FTC "Fake Debt Collectors." 2.2012)

ZIKA Virus: The Center for Disease Control and Radio Broadcast offers these guidelines for avoiding the Zika virus: (1) Avoid traveling to areas where there are Zika virus outbreaks. (2) Take steps to avoid mosquito bites: (a) wear long sleeved shirts and long pants (b) stay in air conditioned places with screens on the windows and doors to keep mosquitoes out (c) Use EPA registered insect repellants, and (d) stay away from mosquito breeding places like open containers of water.




The Texas Department of State Health Services reports 96 cases of Zika in Texas as of 11:00 am, Aug. 5. The first death in Texas occurred in Harris County. An infant died on Aug. 9. The most common symptoms include fever, rash, joint pain and conjunctivitis. Zika is associated with microcephaly in infants.
