WHO ARE YOU VOTING FOR AND WHY?

Recently, TRTA provided a series of articles through the *Inside Line* e-newsletter about "Good Voter Health." What constitutes "Good Voter Health?" "Good Voter Health" is a term used to describe an active and informed member of the voting community.

While there are several key factors in exercising your voter muscle, the first is that you **always VOTE!** In Texas, your vote matters more in the Primary Election held in March than the General Election in November.

Many races are decided in the primary elections, but few voters turn out for these spring races. TRTA is here to tell its members that voting in the primary election is more than just important, it is vital!

Need more evidence? In 2014, a primary election seat between two Republican candidates was decided by a mere 92 votes. In this race (HD 115), only 9 percent of registered voters determined the outcome. Because the historical voting data in that district demonstrates a pattern toward Republican representation, the November General Election held little sway on the final result. This election was decided in the March primary.

This is true for the majority of House and Senate districts in Texas. Handfuls of voters are casting ballots that ultimately determine the final outcome.

WHO ARE YOU VOTING FOR AND WHY?

Your power as a voter is amplified in primary elections simply because so many other people

choose not to vote. Occasionally, the candidate from the political party most likely to win the primary election does not represent your ideals. If you are in this situation but you do not want another influential interest group to take away your power in the November general election, consider voting in the OPPOSITE party primary and choosing a candidate you believe may be friendlier to TRTA issues.

TRTA is not suggesting that you disregard your political ideals or that you vote for someone you do not support; however, the primary process offers a choice of candidates, some of whom may support the TRTA legislative agenda. If you think your vote may be better used in this way, this may be a winning strategy for gaining support for TRTA issues during legislative session.

Some members may agree with the likely victorious political party in their area. This does not mean, however, that the party's candidate who won the primary is the person you want representing you on vital TRTA legislative issues.

It is easy to take for granted our favorite candidate's chances of election, but we must remember that when a candidate faces a challenger in the primary, the vote could go either way!

wer Who Should I Vote For?
Ask yourself the right question: "Who should I vote for, and why?"

TRTA does not endorse candidates for political office. TRTA will not tell you who to vote for, but we will always encourage you to ask questions and choose a candidate that supports the interests of public education retirees and pre-retirees.

Our organization has a reputation for working across party lines to establish strong relationships with legislators for the good of TRS and its 350,000+ retirees. We also know that many groups seek to eliminate our defined benefit retirement plan. Some challengers to elected officials in primary elections are supported by groups that want to do away with our retirement system.

TRTA implores its members to talk to each other and ask the following: Who are you voting for and why?

Your fellow retirees may be the best resource in helping you determine which candidate is more favorable to issues impacting the Teacher Retirement System of Texas (TRS). Now is the time to have these important conversations with each other and to learn more about the candidates!

TALK TO EACH OTHER! Share information! Even though TRTA does not endorse candidates, this does NOT mean that we cannot be involved in political activities. The more you learn from the candidates and from each

other, the better informed you will be on the day you vote!

Attend a local unit meeting to converse with retirees in your area and get feedback about who they are voting for and why. You should also reach out to candidates in person, by telephone or by email. Do a search on Google to locate your candidate's website and contact information. One way to get immediate information from candidates is to follow them on social media, such as Facebook and Twitter.

Addressing Candidates about TRTA's Issues

In 2017, when the 85th Legislature convenes, TRS-Care will once again be on the forefront of TRTA's primary concerns. During the 84th Legislative Session, progress was made quickly to address a shortfall nearing \$1 billion for the program, as Chairman John Otto announced that the House would cover the \$768 million in additional funding needed to sustain TRS-Care for two years.

This news was met with great enthusiasm and hope for the future for the 240,000 retirees who utilize the insurance, all of whom live on fixed incomes and rely upon its stable but modest financial security to survive. Fearing a huge spike in premiums, TRTA members sent in thousands of letters to their State Senators and Representatives emphasizing the necessity and importance of the program. The Legislature agreed.

Despite the great news that the Legislature would support the program for the short term, no plans were made at the time to address the funding mechanism and future budgetary concerns that continue to haunt TRS—Care. By 2017, yet another shortfall will occur, to the tune of \$1.5 billion. Over the next year during the legislative interim, a committee of Senators and Representatives will meet to discuss potential solutions.

However, when 2017 arrives, many new legislators will begin their service at the Texas Capitol and be faced with an influx of issues, advocacy groups and lobbyists all vying for their attention.

TRTA and its members must begin the process of educating our political leaders NOW, before the elections occur. Think of every candidate in every Primary Election race as a potential legislator. These are the people who may be making the decisions about whether or not your premiums will increase or your insurance benefits will change.

They need to hear from you—their current or future constituents—about what matters to you and why.

At the end of your email or letter or when you meet them in person, ask your candidates three vital questions:

- Do you support a defined benefit plan for all current and future TRS retirees?
- Do you support providing reasonable, affordable healthcare for TRS retirees?
- What will you do as my legislator to ensure that the TRS fund and TRS-Care are preserved and improved?



Without your involvement during the primary election season and going forward, TRS-Care could be in a much more precarious position. We must continue our vigilance!

Early voting begins February 16 and continues through February 26.

Primary election day is March 1. A complete list of candidates can be found on trta.org or ballotpedia.org. Sign up for the *Inside Line* on the TRTA website to receive up-to-the-minute news about the Texas Primary Elections!

Time is short, the clock is ticking!

When you decide who you are voting for, tell your fellow retirees when they ask about your preferred candidate one of the following:

- 1. "The person I am voting for is a friendly incumbent, and they have helped TRTA. That's more important than what some other interest group is saying about my candidate."
- 2. "The person I am voting for is energized to protect defined benefits and support our health care. I know they are going to be helpful if elected, and while I do not have anything to say about the incumbent, I know the challenger is pro-retired teacher."
- 3. "The person I am supporting is very energized to help us. Unfortunately, the incumbent is heavily supported by organizations that want to do away with the defined benefit plan and thinks TRS-Care is a drain on the state budget. I am supporting the challenger, who is supported by groups interested in our public schools and helping achieve our TRTA goals."

Please consider the following questions and how you would answer them:

- ♦ What does my TRS monthly annuity mean to me?
- ♦ How would I be impacted if I lost my defined benefit annuity?
- ♦ Do I receive Social Security income to bolster my monthly annuity?
- Does my future Senator or Representative understand that 95% of school employees in Texas do not pay into Social Security?
- Do I want the TRS pension fund to be maintained for all current and future education employees in Texas?
- ♦ Do I utilize the TRS–Care retiree health insurance program?
- What is my monthly premium?
- ♦ What are my out-of-pocket medical expenses per month?
- Am I prepared financially to handle any unexpected medical emergencies?
- ◆ Do I feel like I do my part to pay for the existence of the TRS-Care?
- Do I feel like the state does its part to maintain the insurance program?
- **♦** What would I do if my insurance premiums doubled?
- ♦ Do I want TRS—Care to be available for all of the active teachers who pay into the program once they retire?

Now, consider drafting an email or letter to the candidates in your area using the questions above as a catalyst to explain your needs and concerns about your retirement security.

Not only do the candidates need to hear from you, but you need to know if they are committed to YOUR issues. that important, it matters that much, and it is critical to the TRTA agenda. We have to exercise our voting power.

TRTA members should be known as consistent, persistent, confident voters. When legislators and other organizations hear about our members, they should know we will be at the

WHAT ELSE CAN I DO TO SUPPORT MY CANDIDATE OF CHOICE?

If you have contacted your candidates already, and determined who your candidate of choice is, your work as a voter may not be done! TRTA encourages its members to participate in the political process as much as possible.

You may be asking yourself, "What can I do to support my candidate?" Consider the following activities as part of your legislative duty over the next few weeks:



VOTING POWER

Make the decision and a commitment to vote! Convince others to make the same decision and commitment!

- Let your friends and colleagues know who you are voting for and why. It will help them make a more informed decision.
- Share all of the information you learn with your unit, and consider how to make voting fun for your members such as developing a group voting event!



VOLUNTEER

Volunteer to work for the candidate of your choice!

- Call the campaign and ask for a yard sign.
- Give permission to the campaign to put a large campaign sign on your property.
- Volunteer to walk your neighborhood to distribute campaign material for your candidate.

SUPPORT A CANDIDATE

Allow the campaign to use your name as endorsing your candidate.

- Sign up for campaign emails, and pass them on to friends and colleagues.
- "Friend" your candidate on Facebook, and encourage others to do the same.
- Email and telephone your friends and family, and tell them why you support your candidate.
- If you are willing and able, consider making a contribution to your preferred candidate's campaign.
- Ask the campaign for personal endorsement postcards you can use to mail to your friends and family. (Most campaigns are happy to pay for the postage if you will address and sign the cards).
- Write a letter to the editor of your local newspaper and the candidate of your choice about why you support your candidate. The candidate would probably love to use your letter for campaign purposes!



Delegate Information for Districts and Local Units

Names of all convention delegates are due in the TRTA office by March 1, 2016. Local Unit Delegates: Two (2) delegates for the first one hundred (100) TRTA members or fraction thereof; and, one (1) delegate for each additional 100 TRTA members in a Local Unit or fraction thereof. Automatic Delegates: Past TRTA Presidents; Members of the TRTA Board of Directors; Chairmen of the TRTA Standing Committees; District Presidents, First Vice–Presidents, Second Vice–Presidents, Secretaries and Treasurers or alternates appointed by the District Presidents when the elected officers cannot attend.

PROPOSED AMENDMENTS TO THE TRTA BYLAWS

If adopted, the indication of change for each amendment is deleting content by striking through and/or adding content by underlining. Note: No fiscal impact on the organization will be incurred if these proposed amendments are adopted as currently presented.

Amendment 1

If approved, the word "newly" will be deleted which corrects an error in the bylaws which was created by going to biennial officer elections.

Article V: Divisions Section 1-Districts #2

Conduct a Spring Leadership Training Conference to train newly elected Local Unit officers and appointed committee chairmen;

Maker: Organizational Affairs Committee (OAC) Contact Individual: Larry Davis, OAC Chairman

Rationale: Since we went to biennial officer elections, many are not "newly" elected.

OAC Recommends: Approval per our rationale

Board of Directors (BOD) Recommends: Approval Rationale: BOD agrees with the rationale of the maker.

Amendment 2

If approved, will add the Member Benefits Committee, which was accidentally omitted, to the bylaws for Districts, and will change the total number of committees to compensate for the error.

Article V: Divisions Section 1-Districts #5

Have a minimum of eight (8) nine (9) committees: Bylaws, Community Volunteer Service, Health Care, Informative and Protective Services, Legislative, Member Benefits, Membership, Public Relations, and Retirement Education.

Maker: Organizational Affairs Committee (OAC) Contact Individual: Larry Davis, OAC Chairman

Rationale: To add "Member Benefits Committee" to the bylaws for Districts, which was accidentally omitted, and to correct the number count of committees.

OAC Recommends: Approval per our rationale

Board of Directors (BOD) Recommends: Approval Rationale: BOD agrees with the rationale of the maker.

Amendment 3

If approved, will add the Member Benefits Committee, which was accidentally omitted, to the bylaws for Local Units, and will change the total number of committees to compensate for the error.

Maker: Organizational Affairs Committee (OAC) Contact Individual: Larry Davis, OAC Chairman

Rationale: To add "Member Benefits Committee" to the bylaws for Local Units, which was accidentally omitted, and to correct the number count of committees.

PROPOSED AMENDMENTS TO THE TRTA BYLAWS

Amendment 4

If adopted, will change the name of the "Leadership Training Committee" to "Leadership Support Committee."

Article XI: Committees

Section 1

The standing committees of TRTA shall be Community Volunteer Service, Finance, Health Care, Informative and Protective Services, Leadership Training Leadership Support, Legislative, Local Unit Support, Member Benefits, Membership, Organizational Affairs, Public Relations, and Retirement Education.

Maker: Odessa Retired Teachers/School Personnel Association (District 18)

Contact Individual: Ricky Chandler, Odessa RT/SPA President

Rationale: Since the Leadership Training Committee does not actually train anyone, we felt that this new name more adequately reflects the committee's responsibilities. This year's Leadership Training Committee discussed on several occasions the need to change the name and they all agreed at their committee meeting on July 27, 2015 to ask for the name change during the 2016 TRTA State Convention to be held in Houston, TX.

OAC Recommends: Approval

Rationale: OAC agrees with the rationale of the maker.

BOD Recommends: Approval

Rationale: BOD agrees with the rationale of the maker.

Note: If adopted, this name change will need to be made in all other documents of TRTA where the old name of Leadership Training Committee is used.

Amendment 5

If adopted, the Historian will become a voting member of the TRTA Board of Directors and the Board will have eleven eligible voting members.

Article IX: Board of Directors

Section 1

The Board of Directors of TRTA shall consist of voting and nonvoting members, as follows:

1. The voting members shall be the state President, First Vice—President, Second Vice—President, and Secretary/Treasurer; the Immediate Past-President; the Chairman, Vice—Chairman, and Recorder of the District Presidents Council; the Legislative Coordinator; and the Organizational Affairs Coordinator:

2. The Historian shall serve as a nonvoting member of the Board of Directors.

The Board of Directors of TRTA shall consist of the following voting members: the State President, First Vice—President, Second Vice—President, and Secretary/Treasurer; the Immediate Past State President; the Chairman, Vice—Chairman, and Recorder of the District Presidents Council; the Legislative Coordinator; the Organizational Affairs Coordinator; and the Historian.

Maker: Midland Association of Retired School Personnel (District 18)

Contact Person: Ann Parish, MARSP President

Rationale: TRTA has the expense for the Historian to attend all TRTA Board Meetings, but the Historian is the only member of the TRTA Board of Directors without voting privileges. Is it because the Historian is appointed? The TRTA President appoints three members of the Board: Historian, Legislative Coordinator, and Organizational Affairs Coordinator. The Historian is the only one of the three to be given the right to sit in on board meetings, have a voice in the discussion, but he or she is denied the right to vote on the issues that are discussed. Is it because the Historian is not elected or approved by the HOD? Neither are the officers of the District Presidents Council, nor the OAC and Legislative Coordinators. Is it because the Historian does not chair a state committee? Neither does the President, nor the officers of the District Presidents Council.

OAC Recommends: Approval

Rationale: OAC agrees with the rationale of the maker

BOD Recommends: Disapproval

Rationale: If adopted, the majority of the voting members of the Board of Directors will not have been directly elected by the House of Delegates.


