81st LEGISLATIVE SESSION: THE OFFICIAL TRTA WRAP-UP

OFFICIAL NEWS BULLETIN OF THE TEXAS RETIRED TEACHERS ASSOCIATION

This session was perhaps the most challenging one I've experienced in my 14 years of working on behalf of public education retirees.

As the economy fell hard in the 4th quarter of 2008, many of us predicted the upcoming session would be tough. With the TRS pension trust fund losing billions of dollars in value and little hope of the economy turning around any time soon, the mood at the beginning of session was somber.

Still, the Texas Retired Teachers Association (TRTA) had an aggressive agenda. Our members were ready for a fight, and for 140 days straight, we never gave up. Our efforts were tenacious, and the results were better than many thought possible under the circumstances.

Now, it is time to reflect and plan ahead. TRTA will get little rest as we review this session's highs and lows and prepare for the next battle. This association will continue our relentless pursuit of the protection and improvement of your TRS pension benefit.

The Good

The bright spot is an overwhelmingly supportive House of Representatives. Though many State Representatives support TRTA, several champions deserve special recognition.

State Representative Vicki Truitt (R-**Keller):** This session was Rep. Truitt's second as Chairman of the Pensions, Investments and Financial Services Committee. She played a critical role last session in passing legislation that ensured the pension fund's actuarial soundness and allowed retirees to receive a first-ever 13th check.

More recently, this tenacious advocate's efforts not only saved key language that would allow retirees a \$500 supplemental payment, but it was also her bill (HB 3347) that resurrected the matter after a Senate bill died on the House floor just hours before the end of session. In fact, one Senator actually told TRTA the issue was dead and there was no way to revive it. Rep. Truitt and TRTA never gave up, though, and the language was revived, passed, and ultimately signed by the Governor.

House Speaker Pro Tempore Craig Eiland (D-Galveston): Rep. Eiland's steady leadership has kept him in the forefront on TRS funding and retiree benefit issues. This session, he not only served as Speaker Pro Tempore and led a budget crusade to get state dollars needed to reestablish his district's most criticallyneeded services after Hurricane Ike, but he also offered an amendment at 2:40 a.m. after an all-night budget debate in the Texas House that proposed giving retirees a \$1,000 supplemental payment.

Another example of Rep. Eiland's dedication to TRTA: he came off the House floor to speak to the crowd on the South Lawn of the Texas Capitol at the TRTA Rally this April. Moments before he came out, he was presiding over the House in his role as Speaker Pro Tempore. When he heard that TRTA members had assembled outside for their rally, he relinquished the gavel and made

retirees his immediate priority.

State Representative Jim Pitts (R-**Waxahachie):** From the moment Rep. Jim Pitts was assigned as Chairman of the House Appropriations Committee, he was working to provide retirees with as large a benefit increase as possible. Rep. Eiland brought the amendment to the House floor to be added to the budget, but it was up to Chairman Pitts and his team (along with House Appropriations Subcommittee on Education Chairman Scott Hochberg, D-Houston) to find the dollars necessary to support the action.

In the final hours, when time was short and issues were stacking up, Chairman Pitts did not hesitate to help TRTA when he learned that critical authorization language had died, placing education retirees' supplemental payment in jeopardy. He tasked his staff to find a way to pass this needed authorization, and he huddled with the budget conferees to make certain public education retirees were not left in the cold.

State Representative Ruth Jones McClendon (D-San Antonio): Rep. McClendon played a critical role on the House Appropriations Committee, advocating for ways to help education retirees with a benefit increase. A veteran member of the House Pensions and Investments Committee from previous sessions, Rep. McClendon was one of the most vocal members on the House Appropriations Committee about increasing funding for the TRS pension trust fund and finding a way to provide a benefit increase.

Many who attended the TRTA Convention in El Paso last year remember her legislative advice: "When making phone calls, sending emails or writing letters, concentrate on the elected officials that actually represent you; they're the only ones who care what you may have to say, and they know you can fire them if you don't like what they do!"

State Representative John Otto (R-Dayton): For the past two sessions, Rep. Otto's work on the House Appropriations Committee has focused on ways to ensure the fund's actuarial soundness. In 2007, Rep. Otto urged that a one-time 13th check should be viewed as a stepping stone to a more significant, permanent raise for TRS retirees. He commended TRTA members for educating the legislature on the predicament of many retired public education employees whose pensions were not keeping up with inflation.

This past session, Rep. Otto served as a chief budget negotiator in his role as a House Appropriations Committee budget conferee. His work, like that of Rep. McClendon, helped block Senate negotiators from removing a benefit increase for public education retirees altogether.

State Representative Doug Miller (R-New Braunfels): This new legislative member came to Austin with a long legislative agenda. High on that priority list was adding another retiree to the TRS fund's governing board.

The TRS Board of Trustees is the ninemember board responsible for managing the pension trust fund's operations and investments. The trustees are a mixture of private sector and active and retired TRS member appointees. Though there is an election process for the active educator and TRS retiree slots on the board, the Governor still has appointment power over each trustee.

TRTA has advocated for a direct member election process, as well as an additional TRS retiree on the board. Rep. Miller authored HB 2656 to achieve both goals.

The measure passed the House with a vote of 147–0 and went to the Senate. There, the direct election component was removed to appease the Governor, who expressed concerns over not being able to appoint the member. The Senate passed the bill unanimously.

The bill's final passage came on May 29 with a vote of 140–0. On June 19, Governor Rick Perry vetoed it, denying retirees a stronger voice on their own pension trust fund board (see page 4).

In spite of the Governor's veto, Rep. Miller deserves our gratitude for successfully pushing his bill further in the legislative process than any similar legislation has ever gone. TRTA hopes to work with Representative Miller in the future to revive the opportunity Governor Perry just killed.

It is important to note that Representative Miller's bill was not the only one drafted to support this TRTA legislative initiative. We also thank the following State Representatives for drafting similar legislation: Yvonne Davis (D-Dallas), HB 648; Abel Herrero (D-Robstown), HB 688; Roland Gutierrez (D-San Antonio), HB 2144; Todd Hunter (R-Corpus Christi), HB 3998; and Brian McCall (R-Plano), HB 4032.

The Bad

The not-so-bright spot this session was the Texas Senate. Unlike their counterparts in the House, the Senate seemed unwilling to make retirees a priority this session. This was most evident in the debate over the provision of a supplemental payment.

We are disappointed to report that there are few Senators we can recognize for their efforts on our behalf this session. One positive moment occurred in the

Senate when we secured a funding commitment to the TRS-Care program, although in truth, the State <u>is</u> bound by statute to fund the program at a certain level, and we appreciated the Senate's passage of HB 2656. Other than that, though, there is little encouragement as to the Senate's commitment to public education retirees.

The Veto: Promises Made, Promises Broken

In October 2006, Governor Rick Perry responded to the Texas Retired Teachers Association's gubernatorial candidate questionnaire. To the right is a reprinted portion.

On March 6th, 2009, State Representative Doug Miller filed a bill that maintained the number of the TRS Board at nine members, modified its composition by taking one slot away from the State Board of Education (which holds two slots) and reserving it for an elected TRS retiree, and in doing so added stronger representation for the people who actually benefit from the fund.

Q: As governor, would you support the addition of one or more retired members on the TRS Board of Trustees?

A: "...the board currently consists of nine members. I would like to keep the board at nine members but I am

open to the idea of changing the make up of the board so that it would include greater retiree representation. I believe it is important that the individuals who stand to benefit from the wise management of the fund be well-represented."

This bill met every piece of criteria Governor Rick Perry stipulated, and yet it is abundantly clear that he alone is responsible for this bill being defeated.

The management of the fund and the preservation of the traditional defined benefit retirement plan for public education retirees is TRTA's core mission. For nearly 60 years, TRTA has worked for you in the Texas Legislative process. In all that time, we have never chronicled a more direct contradiction of statement vs. action as we did with Governor Perry's veto of HB 2656.

We are beyond disappointed in this veto. Be that as it may, TRTA will NOT let it deter us from reintroducing the issue again next session.

Perhaps most concerning is the failure of the Senate Finance Committee to embrace the use of general revenue dollars to provide retirees a supplemental payment, as proposed by Rep. Eiland. Not only did the Senate refuse to put any money toward a supplemental payment for TRS retirees in their budget proposal; they even argued against the very possibility of a benefit adjustment, citing alleged conflicts with the Texas Constitution and statutory restrictions. TRTA rallied hard in these discussions, but the Senate budget negotiators showed a clear unwillingness to commit to a supplemental payment. One example: a Senate-led reduction on the amount of the \$1,000 payment cap proposed by the House to a cap of \$500.

The fact that a supplemental payment to education retirees (and other public retirees) was held off by the Senate conferees until the very last minute made it difficult to develop an agreeable compromise and reasonably address the payment's legality.

The Senate conferees argued that using general revenue dollars to provide retirees with a supplemental payment would be in violation of Articles III and XVI of the Texas Constitution. Article III deals with a restriction on the State to pay former employees additional compensation for work already rendered. Article XVI deals with the fund being managed with sound actuarial principles; the argument is that making a payment to retirees when the fund is not actuarially sound would be a breach.

After hours of negotiation and numerous delays in finding a final budget compromise, the solution was to appropriate enough money to pay eligible retirees a \$500 supplemental payment if the Texas Attorney General issues a legal opinion that it is permissible.

I cannot accurately convey our disappointment in the Texas Senate without mentioning a critical piece of information. Last session, the state contribution was set at 6.58 percent. The independent TRS actuary has since warned against the reduction of that percentage, and yet the Senate led budget discussions this session by lowering the contribution to 6.4 percent. In plain terms: in the worst economic downturn in the entire history of the TRS pension trust fund, during

a time when independent experts are issuing clear warnings against reducing the funded contribution level, the Senate proposed a reduced contribution to the TRS fund anyway.

Some might argue that TRTA is not seeing the big picture. They may contend the money that would be used to support TRS would instead provide retirees with a \$500 supplemental payment. This argument would have more credibility if the Senate had maintained its proposed level of support to the fund in the months leading up to the last–minute debate on the payment, or if they had proposed a long–term increase in funding to TRS. Unfortunately, neither of these scenarios occurred.

The issue is not dead, though. An official Texas Attorney General opinion will determine whether you will receive your supplemental payment, and TRTA's Board has hired the law firm Morgan Lewis to file a legal brief on the issue. Looking Ahead

TRTA is always in planning mode for the next legislative session. Here are some of the top issues we expect to dominate the next session:

Pension Funding—There is no doubt that adequate funding of the TRS pension trust fund will be a primary TRTA issue. Legislators need to consider the following in the interim: The TRS Pension Fund has never suffered as large a drop in its actuarial condition as it did from August 31, 2008 to February 28, 2009. The legislature responded by reducing its funding to TRS. Even the independent TRS actuary advised the legislature to, at a minimum, maintain the funding level from the previous biennium, but it ignored this advice and reduced its commitment.

Benefit Increase — Next session will mark the 10-year anniversary of the last permanent increase in TRS retirement benefits. (An interesting tidbit: Legislators gave themselves a permanent retirement benefit increase in 2005.)

Health Care Funding—The fact that TRTA helped ensure adequate funding for TRS—Care this session is not a guarantee that the legislature will fully fund its portion of this critical program, even though it is required by law to fund it at a certain level.

Health Care Delivery – Legislation was proposed this year (without the counsel of TRTA or any other member-based constituent group) to test new theories and practices on some TRS–Care participants. TRTA successfully argued that the approach was not the best way to introduce a "paradigm shift," as it was being called. The plan was shelved, but we are preparing for the issue to return next session.

Pension Dollars for State Projects — There has been much legislative discussion about how the TRS pension trust fund could invest in state toll roads. We have no issue with the TRS Board investing in infrastructure projects. We do, however, have a problem with the Texas Legislature and/or Governor forcing the TRS Board to invest in Texas infrastructure initiatives in order to

You've Got Mail: Education Retirees Make Waves with Texas Legislature

New Email, Phone Campaigns Reach Legislators in Record Numbers

This session TRTA used a new method to lobby lawmakers and convey our thoughts on issues affecting public education retirees. Through an innovative email service, members can now access their lawmakers in just a few clicks of a mouse.

This spring, TRTA's state office sent out special issues of the "Inside Line" asking readers to click on links to pre-drafted letters explaining TRTA's stance on specific topics and bills. The letters could be personalized to fit each member's viewpoint, or simply sent "as is." The system uses ZIP codes to determine which legislative district the sender resides in and offers the option of adding other legislators as needed. To keep our messaging clear about separate issues, on two occasions members were asked to place telephone calls to legislators serving their areas, as constituent calls are of utmost importance in the critical moments before a bill is passed or voted down.

The numbers are stunning. One four-day period in particular, more than 6,300 emails were sent in support of the much-needed supplemental payment for public education retirees. In all, TRTA members sent nearly 50,000 emails to the Texas Legislature and placed more than 7,000 phone calls about the issues that mean something to us.

TRTA members are active. We are loud. We work together as a team. As a result, every single Texas legislator received an email from a TRTA member this session. This is just one example of how amazing, energetic and dedicated the retired educators of Texas are, both as individuals and as an interconnected statewide team.

Although the 81st Legislative Session was a difficult one, we are positioning ourselves as a force to be reckoned with—a tactic that will prove handy as our battles continue. When we come together and join forces toward a common cause, anything is possible.

finance the projects they do not have the resources or the will to fund themselves through other means.

Other Pitfalls—TRTA is monitoring the political outcomes in many other states to track national trends in public pension plans. TRTA will stand vigilant against harmful actions such as pension–funding holidays, health care reductions and prescription drug plan changes. The TRTA Board and Legislative Committee will be ready if/when they appear in Texas.

Concluding Comments

We pride ourselves on being the voice for all retired public education employees. This session was hard, and the results were less than inspiring. Imagine, though, what may have happened to current and future retirees without the efforts of TRTA

members. The outcomes would have been far less favorable in contrast.

Our most important resource we can draw upon to advance our legislative agenda is YOU. When times are tough and people question whether their membership in TRTA matters, YOU must remind your fellow retirees that we must stand together or fail. The global economic downturn is putting pressure on pension systems unlike any other time in our history. We must remain strong and active to protect what we have worked so hard to attain.

Your dedication to TRTA is appreciated more than you know. Your efforts have a profound impact on the Texas legislative process and thank you for your work this session.

TRTA Takes Over the Capitol

Former educators leave a lasting impression with state legislators at the Capitol

More than 600 TRTA members climbed into buses and cars the morning of Wednesday, April 22 and converged on the Texas State Capitol to thank our legislators for keeping former educators' issues alive in the House and Senate. TRTA Day at the Capitol brought together former teachers, principals, coaches and other public education system personnel in a stunning visual display of bright red shirts and tote bags blanketing the Capitol grounds throughout the day. The reminder served to keep lawmakers aware of the sheer volume of Teacher Retirement System of Texas (TRS) retirees who vote.

"One in every 20 Texans is a part of TRS," said TRTA President Dora Scott-Nichols during her address on the South Steps of the Capitol that afternoon. "We comprise a huge portion of the state's population, and our spending power has been limited by the current economic climate. Our lawmakers must remember that retired public education employees haven't seen a cost-of-living raise since 2001, and yet we still continue to give back through mentoring, book drives and other acts of community service."

Inside, House Speaker Joe Straus, R-San Antonio, recognized TRTA members on the House floor and Senator Duncan followed suit in the Senate. Both commended TRTA members for their years of service to the state and postretirement contributions to our communities. Afterward, legislators stopped by the Old Supreme Court Courtroom to meet retired educators from their districts and take photographs to send back home. Later in the day, legislative staffers joined

TRTA members on the East Lawn for an old-fashioned ice cream social. At every event throughout the day, a special onepage handout was given to Capitol staff and elected officials to remind them of TRTA's legislative priorities.

To reiterate the value of our contributions to the state of Texas, TRTA presented legislators with a facsimile check for more than \$101 million to illustrate the amount of state revenue saved through our members' community service hours. We also highlighted the fact that we have delivered more than

400,000 books into the hands of young Texans through our annual Children's Book Project and done our part to cut healthcare costs by participating in the Walks-A-Million program.

Since the event, Capitol insiders have shared privately that we could not have chosen a better time - or a better tactic to reach out to Texas lawmakers and remind them that we are here, we vote, and we need their help. In the future, TRTA will look back and use April 22, 2009 as a blueprint for all legislative outreach events.



Bowie County Memorial Honors Local Retired Educators

Western Bowie County Retired Teachers Association (RTA) president Juanell Cagle has realized a long-awaited dream of having a memorial for Bowie County school employees.

She and her husband, Roy, a former New Boston Independent School District superintendent, are excited that it has finally become a reality. The new monument with hundreds of names sits right in front of the Bowie County Courthouse in New Boston.



Cagle said there are currently 386 names engraved along the wall running below the memorial. It became a reality when the Texarkana-Bowie County Retired School Employee Association and Western Bowie County RTA teamed up to recognize the efforts of teachers and staff who have touched the lives of children in public schools.

Cagle organized the dedication because the project is near and dear to her heart. She believes it is a wonderful way to honor those who have worked in the public schools in Bowie County.

Bowie County Judge James Carlow said the memorial is long past due.

"We already have several hundred names listed and we appreciate the work and dedication of those people who are no longer with us, who made a difference in the children they taught or influenced," he said. "The courtyard at the courthouse is the appropriate place to display such a memorial, and it's an honor to have it in front of the building."

Pat Henry, Texarkana-Bowie County Retired School Employee Association president, offered the invocation and pledge of allegiance at the event.

"Public education came to Texas in 1840... [it] is dedicated to young people," said Nick Blain, a past president with the Western Bowie County RTA.

He said the memorial not only recognizes teachers, but also the janitor, the cafeteria worker, and any person who touched the lives of children.

TEXAR Federal Credit Union sponsored the funding for the project.

You MUST receive your paycheck from the ISD, NOT from a third–party employer to be eligible for this insurance and you MUST be a TRTA Regular Member. The TRTA–endorsed group professional liability plan through John A. Barclay, Inc. has an annual charge of \$39.00 per person.

Insurance Premium per Member \$35.00 + State Taxes and Fees (4.91%) \$1.72 + Association's Administrative Fees \$2.28 = TOTAL \$39.00

The policy pays:

- ◆ Coverage A: Up to \$1,000,000 per insured, per occurrence/\$3,000,000 per occurrence



CLASSROOM ASSISTANCE GRANTS

The Texas Retired Teachers Foundation (TRTF) recently announced its 2009–10 Classroom Assistance Grant winners. This year, TRTF awarded four \$500 grants to public school teachers throughout the state.

Prior to Hurricane Ike, Sara McCurry taught fourth grade at Burnet Elementary school in Galveston. Unfortunately, the school was flooded during the storm and is still closed. Sara and 15 of her 20 students relocated to Parker Elementary. "The school district did a wonderful job of getting the schools back open as soon as possible," says Sara. "Of course, this also meant moving to another school with virtually nothing."

During the storm, Ms. McCurry lost all of the listening stations that she used to improve students' reading fluency and comprehension. Although she received a brand new listening station, her class has been unable to use it due to lack of resources. She is purchasing new books and CDs in a variety of reading levels with the \$500 grant she received from TRTF. Sara plans to share her new reading resources with her fellow teachers, allowing many students to benefit from the grant.

Throughout this experience, Sara says she has witnessed resilience from her students. Some of them lost everything, including school supplies. "Although this year is much different than where we started, I truly believe that we have had just as much success as any other year," she says. "The students are happy and looking forward to starting 5th grade and middle school next year."

Sara is thankful for the support she has

received from fellow teachers, volunteers and anonymous donors from around the state. Sara says it took everyone working together to bring a sense of normalcy back to the classroom. The grant provided by TRTF will be instrumental in bringing many students a familiarity of life before the storm. TRTF wishes Sara and all the students

in Galveston continued success.

Classroom assistance grants were also awarded to Genevieve Moore, Kristi Curtis, and Denise Clay (above).

Genevieve Moore, a first grade teacher at Norma Krueger Elementary in Marion, will use her grant to purchase supplies and equipment for a science cart. The science cart will contain items such as goggles, petri dishes and thermometers. Purchasing the equipment, which will be shared among pre-kindergarteners through second graders, will allow "each class (to) have small cooperative groups working to conduct investigations," says Ms. Moore. Ultimately, Ms. Moore hopes these materials will help her students engage in hands-on activities that will improve their TAKS scores.

Kristi Curtis teaches first grade at Wheatley Elementary School in Lubbock. In order to integrate reading strategies into social studies and science instruction, Ms. Curtis will purchase copies of Scholastic News and National Geographic Young Explorer for every first grade student on campus. In class, Kristi will use the publications to highlight high frequency words and content vocabulary and practice fluency through repeated readings. She also hopes the magazines will serve as a springboard for writing.

Denise Clay teaches at Brabham Middle School in Willis, Texas. She has approximately 120 students in her sixth, seventh, and eighth grade ESL classes. Her \$500 grant will create a multi-reading level classroom library designed for struggling readers. The books will help her students master the English language, improve their independent reading levels and encourage them to read on their own. Denise will be able to purchase nearly 100 books for her classroom library with her grant from TRTF.

This tremendous gift will allow TRTF to provide scholarships for college students, and aid to retired school personnel for a one–time special need or hardship.




