TRTA BUILDS A TABLE FOR CONGRESSIONAL ACTION ON GPO/WEP By Tim Lee, Executive Director

Many of you may recall the popular movie about a farmer who built a baseball field on his land. The motivation behind the man's ambition was a voice that kept telling him, "If you build it, they will come." Similarly, the TRTA Board of Directors is moving forward with an approach to "build" a table in Washington and add pressure to Congress on the repeal of the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP).



Many of you know the effects of the GPO, the WEP or both on a very personal level. These unjust Social Security provisions reduce and, in some cases, eliminate benefits for public education retirees, as well as many other public employee retirees. TRTA has chronicled the history of these two provisions and their impact in previous issues, but as a refresher for those who have never heard of the GPO and the WEP, visit www.trta.org for more information.

The bottom line is that public pensioners all over the country are being penalized for their service. The impact is felt by educators, municipal workers, state employees, federal employees and even the United States military.



With hundreds of thousands of Americans hurting from the financial impact of the GPO and the WEP, why has Congress failed to act? In an era of bailing out the big banks and financial institutions, why has Congress turned its back on public employees who have spent their lives in service to our schools, fire stations, communities, and even on the battlefield? The only plausible answer is that Congress believes they can continue taking money from retirees with little to no action on the issue. Hundreds of Congressional members find solace in cosponsoring legislation that calls for the repeal of these provisions, while never taking any

definitive step toward that end. All the while, retired public employees are heavily recruited to support the same Congressional members when it comes time to go to the ballot box. These same retirees are being ignored, misled, and cast aside for issues Congress believes are more important.

Can such a claim really be made about Congressional officials who profess their desire to see these issues reversed? The proof is in their actions. The GPO and the WEP are simply punted from one Congressional session to the next with little more than a symbolic cosponsor list and an occasional committee hearing. The issue has been raised with Congress consistently for more than 20 years, and although awareness of GPO/WEP is as high as it has ever been, Congress still fails to make it a realistic priority.

Repealing the GPO and WEP Requires a New Approach

Have you ever tried to make an appointment with a Congressional office? The sad reality is that Congressional members run at a frenetic pace. Traveling between Washington and their districts, going to innumerable meetings, visiting with as many constituents as they can these are but a few of the scheduling obstacles that tend to get in the way. TRTA is rethinking the entire outreach effort on the issue and organizing the first-ever GPO/WEP Summit. This initiative began nearly two years ago when TRTA and the Retired Educators Association (REA) network met to discuss our collective progress and design a new approach.

The REA network is an organization of retired public education associations

around the country. TRTA functions in partnership with these organizations on a national level through the National Retired Teachers Association as well as other nationally affiliated groups. With nearly every state in the country having a retired educator association, the REA network adds to our collective strength in Washington on issues such as this one.

TRTA and many other REAs decided Congress was simply doing the minimum to placate our constituency. Unfortunately, Congressional members across the political spectrum have simply been taking advantage of the retirees impacted by the GPO/WEP by signing a bill professing their support, but taking little real action to advance the issue. In spite of this inaction, though, we have made considerable progress educating other retirees and making active employees aware of the GPO/WEP.

A Blueprint for Success

In the many years TRTA and other REA groups have been working to repeal the GPO/WEP, few instances can be cited in which Congressional activity has actually brought decision makers to the table to advance the GPO/WEP repeal effort. Every now and then, a hearing or press conference is held, but they are few and far between and have had minimal effect.

Therefore, TRTA is reaching out through the upcoming GPO/WEP summit and asking Congressional members to explain in person to our network just what actions they are taking and what activities we can undertake to repeal these harmful provisions.

Right now, TRTA is scheduling Congressional members to meet with REA network leadership on the real and tangible aspects of a repeal. Summit participants want to know what exactly is being planned for Social Security reform, how the repeal of the GPO/WEP fits into those plans, when we can expect real action, and what our members can expect from all involved.

We also plan on having representatives from the Social Security Administration, various Congressional staffers, and our allies from other state and national constituent groups at the summit to work with us. The summit's success, though, relies primarily on the participation of the Congressional members we're counting on to move this issue forward. We need to hear from them what they are doing to push this issue forward. We need to know what the resistance is, what the current financial estimates for repeal are, who is working with us, and what our members can expect Congress to do now.

TRTA may need your help. As we continue to make contact with Congressional members, we know their calendars are not set until just a few weeks or even days before any given meeting. The more constituent pressure TRTA members can generate on their representatives' participation, the more likely it is that each Congressional member will schedule time with us.

Keep in mind that this approach has never been tried before, and we are doing something very different than a simple Congressional office visit. TRTA has secured a meeting room inside the United States Capitol to make it as convenient as possible for key members of Congress to join us. While we are not inviting the entire Texas delegation, we need to meet with several critical members. TRTA members can follow the summit's

Who Else Is Helping with This National Effort?

Many organizations are working to repeal the GPO/WEP. Nearly all of the active teacher associations, administrator groups, and other organizations representing active education employees want to abolish these provisions. Many other public employee organizations, including state and federal employees, are working to rid the system of them as well.

Some states are developing grassroots organizations on their own to repeal the GPO/WEP. For example, a group of active educators in California are working with the California Retired Teachers Association and many other groups to host statewide rallies and awareness campaigns. The group's web site, www.ssfairness.com, offers many additional resources for your review.

TRTA is working to add even more groups to these efforts. Only when Congress feels pressured enough on this issue will they choose to act. It will take all of us working together to make an impact.

The Bottom Line

With these efforts in full swing, TRTA expects Congress to be much more responsive to our members when it comes to the GPO/WEP. Much has been done to help push Congress into action. Thousands of letters and countless emails have been sent, more Congressional

visits than I can remember have been made, and this is but a scratching of the surface. The last reported price tag on repealing the GPO/WEP was purported to be over \$85 billion in a ten-year period. Think about the billions Congress has spent in the last year just to bail out banks and save Wall Street power brokers. All the while, hundreds of thousands of public servants across the country have waited to know if their Social Security benefits may ever be restored. Helping retirees receive their full Social Security benefits should stimulate the economy and assist state and local governments through sales taxes generated on the consumption of goods and services.

TRTA is no longer doing "business as usual." Congress has had it the same way for far too long. Retirees know the drill and we are dismayed to think that Congressional members would not expect us see what they have been doing (or, more to the point, not doing). The reintroduction of the same bills year after year with hundreds of cosponsors but little to no action is one play out of the playbook that we are no longer running. The success of the GPO/WEP summit will be known when we are able to say to you, "We built the table, Congress came to us, and now we have a plan."

The TRTA Board of Directors is fully vested in this summit. The elected TRTA officers, the State Legislative Coordinator and I will all be participating in this event. A complete report on the summit and its results will be printed in the next issue of *The VOICE*. We will also provide email updates through our *Inside Line*. The money now being deposited into the fund is barely a drop in the bucket in terms of the overall picture, but it would have meant the world to those receiving it in the form of a supplemental payment that could have gone toward groceries, medicine or utility bills this winter. We are now more emboldened than ever to fight tooth and nail for what has been promised to us. Especially now, we will not back down.

Still, retirees have much to celebrate despite this year's tough economy. We are fortunate to have a defined benefit plan which guarantees our monthly annuities. The TRS fund is beginning to regain its strength. Those of us with TRS Care II and III have had no premium increase, enabling us to continue purchasing the prescriptions we need. For these good fortunes, if few others, we are thankful.

Last year's volunteer service reports showed that we distributed 81,000 books to deserving children through the Children's Book Project and took more than 27 billion steps as part of the Walks-a-Million program, doing our part to adopt healthy habits and reduce health care costs. We gave more than \$101 million dollars' worth of volunteer hours, saving Texas a substantial amount of money in the face of economic adversity. This year's deadline for reporting our local service hours is December 31. Let's do all we can to surpass last year's benchmarks!

We had a fantastic convention this past spring and are looking ahead to the 2010 event. Please be sure to read our special convention section on pages 6–8.

Thank you for your state association membership. If you are not already a member of a local TRTA unit as well, I encourage you to become one. Our local units are the backbone of our association. Coach Gene Stallings Keynote Speaker

At the conclusion of the 1996 season, Coach Gene Stallings announced his retirement from the University of Alabama. One of legendary coach Paul "Bear" Bryant's favorite coaching sons, Stallings was named Alabama's 22nd head football coach Jan. 11, 1990. He had first worked at Alabama as an assistant coach in 1958 and returned after working in the NFL for many years [including as St. Louis Cardinals head coach]. In seven years, Stallings directed the Crimson Tide to one National Championship [1992], one SEC Championship, four SEC Western Division titles and six post-season bowl appearances. His on-the-field coaching record stands

as 70–16–1 [.810], a winning percentage fourth in Alabama history. A graduate of Texas A&M, Stallings spent a total of 14 years as a college head coach with an overall collegiate record of 97–61–2. Twenty of his former players have gone on to play in the National Football League. His book, Another Season, describes the love he has for his son who was born with Downs Syndrome. Stallings has received several humanitarian awards and was selected as 1992 National Coach of the Year. He speaks on family relations and leadership topics.

Texercise and the Texas Retired Teachers Association: A Healthy Partnership

Physical activity and proper nutrition can improve your health at any age or fitness level. In addition to burning calories and strengthening your body, physical activity can lower the risk of developing chronic health conditions such as diabetes, hypertension, cancer, heart disease, high blood pressure, and obesity. Activity can improve balance and strength and slow the loss of bone mass, which leads to osteoporosis. As a result, physically active people require fewer hospital stays and physician visits, use less medication than those who are physically inactive and spend less on medical needs.

To help all Texans adopt healthy lifestyles, the Texas Department of Aging and Disability Services (DADS) developed Texercise, a statewide fitness program that educates and involves individuals and communities in physical activity and proper nutrition throughout the lifespan.

It provides a variety of educational and motivational resources to help all Texans adopt healthy lifestyles. Two of Texercise's most popular resources are its handbook and DVD, both of which contain information about the program, as well as fitness facts and nutrition tips.

Another way Texercise reaches Texans is through our public, private and non-profit partners. The program's partnerships build our state's capacity for providing fitness and nutrition options, raise public awareness of DADS and the aging and disabilities network as well as provide opportunities for Texercise partners and their employees to engage in options that support healthy living.

Because of valuable partners like the Texas Retired Teachers Association (TRTA), Texercise is able to connect with people across the state and share life enhancing information and opportunities.

2010-2011: RUNNING FOR TRTA OFFICER POSITIONS

If you are a qualified member interested in running for a TRTA office for the year 2010–2011, please complete the filing form and submit it to the TRTA office (deadline is January 15, 2010). The form can also be downloaded at www.trta.org. In accordance with the TRTA Bylaws, the elected officers of the association shall be President, First Vice–President, Second Vice–President, and Secretary/Treasurer. Below are steps governing the election of TRTA Officers:

Officers of the Organization, Article VII, Section 1.1

TRTA shall have the following statewide officers, who shall be elected or appointed as specified:

1. The officers elected by the House of Delegates shall be the President, First Vice-President, Second Vice-President, and Secretary/ Treasurer. A candidate for any of these offices shall have been a participating member of TRTA and of a Local Unit for at least three (3) years, and shall have served as an elected officer of a District or Local Unit, but need not have served as a statewide officer.

Nominating Committee Guidelines TRTA Operations Policy

1. The Nominating Committee shall solicit nominations for elections to statewide office in the September and December issues of the TRTA publication. Nominee forms should be requested from the TRTA administrative office and must be completed and returned to that office with photos, postmarked no later than January 15. All nominees meeting the established criteria, as determined by the Nominating Committee, shall be candidates for the respective offices. Biographical data and photos of all candidates shall be published in the February issue of the TRTA publication.

Campaigning for TRTA Office/Position TRTA Operations Policy

Campaign procedures to be followed by all candidates for TRTA office are:

- 1. Whether announced or unannounced as a candidate for a TRTA office, the campaigning period shall begin 90-days prior to the start of the TRTA convention and conclude upon the election of TRTA officers.
- 2. TRTA shall not pay campaign expenses incurred for any
- 3. Name and address mailing labels of district and local unit presidents, and the Board of Directors, may be provided to TRTA officer candidates upon written request to the Executive Director. A payment of \$25 is required. The request must indicate that the label information will be used only in the campaign for the current office sought.
- 4. A request for mailing labels shall be discussed only with staff and/or officers, and only for the process of providing the labels.

Elections, Article VIII, Section 2

1. The House of Delegates shall elect the officers by secret ballot at the annual TRTA Convention. A majority vote shall elect. If no majority vote is achieved, a run-off election shall be conducted between the two (2) candidates receiving the most votes. If there is only one (1) nominee for an office, a vote for that office may be by voice.

THIS IS THE SEASON TO IMAGINE

Recently you may have noticed a special envelope in your mailbox from the Texas Retired Teachers Foundation (TRTF). This is because for the first time in over three years, TRTF is sending a direct appeal letter to the members of the Texas Retired Teachers Association (TRTA) to solicit donations.



The letter is being sent in conjunction with Foundation month, a time to raise awareness of the Foundation's charitable activities.

You may be wondering why TRTF sent this letter to you. After all, TRTF includes a donation card on the back page of *The VOICE* every quarter. The simple answer is that TRTF needs your help.

TRTA members are the backbone of the Foundation. It is because of your generosity that TRTF is successful in its philanthropic activities. In 2009, the Foundation distributed \$5000 to students pursuing degrees in education and \$2000 to teachers for innovative classroom projects. TRTF is also launching a pilot version of its newest endeavor, "A

Helping Hand," in the fall in four TRTA districts: 8, 12, 17, and 20. "A Helping Hand" aids retirees in critical need.

TRTF will not mail multiple requests for donations to you. Additionally, TRTF is not using common direct mail gimmicks, such as address labels supplied by external vendors. "We want the members of TRTA to know that the donations they send go directly towards programs they care about, and not to an outside mail house," says Board President Tom Pritchard.

It can be difficult at this time of year to include donations to your favorite charities in your budget; but if every member gave as little as \$10, TRTF would be able to raise an astounding \$700,000! This money in turn can aid countless individuals who need help the most. As Tom Pritchard says, "We are asking people to imagine the good that can come from their gesture!"

What does TRTF imagine in 2010? TRTF will award ten \$500 scholarships to students pursuing degrees in education and ten \$500 grants (\$3000 more than last year) to Texas public school teachers. TRTF will help retirees across Texas with dire needs, such as replacing broken air conditioners or heaters or paying for unexpected medical bills.

The deadline for submitting completed applications for each program is March 18, 2010. For the 2010–2011 school year, TRTF will award ten \$500

student scholarships and ten \$500 classroom assistance grants.
