Since TRS is prohibited from lobbying the Legislature, TRTA is their voice! The Legislative Committee of TRTA initiates and supports legislation and opposes legislation that might be harmful to the solvency of the TRS trust fund.

TEACHER RETIREMENT SYSTEM OF TEXAS (TRS)

TRS was established by the Texas Legislature in 1937. It was established to benefit both the active and retired educators. The current role of TRS is to collect contributions, invest the funds, pay annuitants, and administer TRS-Care. As a state entity, the role of TRS is determined by the Legislature.
