## STEP 2

The Teacher Retirement System of Texas (TRS) was officially formed in \_\_\_\_\_ with the passage of enabling legislation.

TRS has two core responsibilities: to \_\_\_\_\_ retirement and related benefits that have been authorized by the Texas Legislature, and to \_\_\_\_\_ the fund that finances member benefits. However, TRS \_\_\_\_\_ influence the Legislature on any laws regarding the system.

It is very important to contact TRS at least \_\_\_\_\_ months prior to your anticipated retirement date. TRS provides state-wide Retirement Benefits Group Sessions and an Individual Field Counseling Session which can be scheduled online; individual Austin visits may be scheduled by phone. Most Texas public employees do not pay into the federal \_\_\_\_\_ program and TRS is their sole form of retirement security.
