## **Cy-FARE Membership and Dues**

## **MEMBERSHIP DEFINITIONS:**

- A. Any retired school personnel or beneficiary who is an annuitant from a teacher retirement system may become a member of TRTA upon payment of dues, either through a Local Unit or directly to TRTA.
- B. Any person who is interested in education and desires to promote the objectives of TRTA may become an Associate Member of TRTA upon payment of TRTA dues either through a Local Unit or directly to TRTA. Associate Members shall have all the rights and privileges of membership except the right to vote and to hold office in TRTA.
- C. Members of all local units must also join TRTA.

**PAYMENT OPTIONS FOR DUES** - Annual dues for TRTA of both Active TRTA Members and Associate Members shall be thirty-five dollars (\$35). In addition, Cy-FARE local dues for both Active Cy-FARE Members and Cy-FARE Associate Members shall be ten dollars (\$10).

- 1. **Option 1** Enroll in Payroll Deduction from TRS Annuity Check of \$2.92 each month and in addition, complete the Cy-FARE Membership form and pay \$10 local Cy-FARE dues.
  - a. Must receive a TRS Annuity to enroll in Option 1.
  - b. Two forms need to be completed for Option 1 the TRS-593 form and the TRTA Enrollment Form.
  - c. The TRS-593 form is available for downloading from <a href="www.trta.org/TRS593">www.trta.org/TRS593</a> Please do NOT mail to TRS as the top of the form requests.

  - e. Complete both forms and on the TRTA Enrollment Form check Option 1 and mail both forms to: TRTA, 313 E 12th Street Suite #200, Austin, TX 78701.
  - f. For Local Dues: Complete the Cy-FARE Membership Form and send with \$10 check payable to "Cy-FARE" each year and mail to: <u>Cy-FARE, PO Box 2368, Cypress, Texas</u> 77410-2368.
- 2. **Option 2** Either enroll in Monthly Bank Draft of \$2.92 from your bank account for TRTA or pay \$35 TRTA directly by check or credit card to TRTA. In addition, you will need to pay an additional \$10 local Cy-FARE dues.

  - b. Fill out the top part of the TRTA Enrollment Form and check Option 2. Complete the bank draft information on Option 2. Be sure to sign the form, and attach a voided check (deposit slips are not accepted).

- 3. **Option 3** Payment of TRTA Dues and Cy-FARE Dues together yearly.
