The roll of TRTA has changed dramatically since TRS was prohibited from being an advocate for retirees. TRTA must now gather information from its members and TRS to determine TRTA's goals for the upcoming legislation session and present them to the state legislature.

The Legislative Committee of TRTA initiates and supports legislation favorable to TRS annuitants and opposes legislation that might be harmful to the solvency of the TRS trust fund. TRTA can be successful in the above tasks *ONLY* if *ALL* public school and higher education retirees (TRS annuitants) join the Texas Retired Teachers Association!!!

## **TEACHER RETIREMENT SYSTEM OF TEXAS (TRS)**

TRS was an advocate for the improvement of benefits to public school and higher education retirees to the Texas Legislature until 1995 when the 74<sup>th</sup> Legislature passed a law prohibiting advocacy by TRS for retirees or active employees. The current role of TRS is to collect contributions, invest the funds, pay annuitants, and administer TRS-Care. As a state entity, the role of TRS is determined by the Legislature.
