Cy-FARE Membership and Dues

MEMBERSHIP DEFINITIONS:

- A. Any retired school personnel or beneficiary who is an annuitant from a teacher retirement system may become a member of TRTA upon payment of dues, either through a Local Chapter or directly to TRTA.
- B. Any person who is interested in education and desires to promote the objectives of TRTA may become an Associate Member of TRTA upon payment of TRTA dues either through a Local Chapter or directly to TRTA. Associate Members shall have all the rights and privileges of membership except the right to vote and to hold office in TRTA.
- C. Members of all local chapters must also join TRTA.

Cy-FARE Membership Payment Options

TRTA Membership Payment Options www.trta.org

- 1. Monthly Bank Draft—Available to members and associate members. Dues drafted from member's designated bank account in monthly installments of \$2.92.
- 2. Monthly Pension Deduction—Available to TRS annuitants. Dues paid in monthly installments of \$2.92 withheld by Teacher Retirement System of Texas (TRS) and paid to TRTA.
- 3. Annual Payment—Available to members and associate members. Dues paid by member directly to TRTA of \$35.00 by cash, check, credit card or money order.
