

Official Rules: TRTA Grand Canyon Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Sponsor

The TRTA Grand Canyon Giveaway ("Giveaway") is sponsored by the Texas Retired Teachers Association (TRTA).

Eligibility

The Giveaway is open only to individuals who:

- Are legal residents of the United States.
- Are at least 18 years of age at the time of entry.
- Become a **new TRTA member** between **March 1, 2026, and July 31, 2026**.
- Are eligible for TRTA membership under the organization's membership guidelines.

Current TRTA members are not eligible to enter unless they qualify as a new member under TRTA membership policies. Employees of TRTA and their immediate family members may be excluded from participation.

Giveaway Period

The Giveaway begins at **12:01 a.m. Central Time on March 1, 2026**, and ends at **11:59 p.m. Central Time on July 31, 2026**.

Membership applications must be submitted and paid in full during the Giveaway Period to qualify.

How to Enter

Eligible individuals will automatically receive one (1) entry upon becoming a new TRTA member during the Giveaway Period.

Limit one (1) entry per eligible new member.

Prize

One (1) winner will receive:

- One (1) Grand Canyon trip provided through Boscov's Travel.
- The prize includes travel for the winner and one (1) guest.
- Scheduled travel dates are **November 1–6, 2026**.

The approximate retail value (ARV) of the prize is approximately \$4,500. The prize is non-transferable and may not be redeemed for cash unless required by law.

Prize Restrictions

The winner and guest must comply with all travel requirements established by Boscov's Travels.

The winner is responsible for:

- Any expenses not specifically included in the travel package.
- Personal spending.
- Required travel documents.
- Applicable federal, state, or local taxes associated with the prize.

Travel dates are subject to the travel provider's schedule and policies.

Winner Selection

The winner will be selected in a random drawing conducted by TRTA on or about **August 1, 2026**, from all eligible entries received during the Giveaway Period.

The drawing results are final.

Winner Notification

The winner will be contacted using the contact information provided during membership enrollment.

If the selected winner:

- Cannot be contacted,
- Fails to respond within seven (7) calendar days,
- Is determined to be ineligible, or
- Declines the prize.

TRTA reserves the right to select an alternate winner.

General Conditions

TRTA reserves the right to cancel, suspend, or modify the Giveaway if fraud, technical failures, or any other factor impairs the integrity of the Giveaway.

TRTA reserves the right to disqualify any individual who tampers with the entry process or violates these Official Rules.

Limitation of Liability

By participating, entrants agree to release and hold harmless TRTA, its officers, directors, employees, volunteers, Boscov's Travels, and their respective affiliates from any liability arising from participation in the Giveaway or acceptance or use of the prize.

Privacy

Information collected through the membership application process will be used in accordance with TRTA's Privacy Policy and for the administration of the Giveaway.

Governing Law
