

Official Rules: TRTA Not Back to School Giveaway

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Sponsor

The TRTA Not Back to School Giveaway (“Giveaway”) is sponsored by the Texas Retired Teachers Association (TRTA).

Eligibility

The Giveaway is open only to individuals who:

- Are legal residents of the United States;
- Are at least 18 years of age at the time of entry;
- Are current, paid TRTA members at the time of entry and
- Provide accurate, up-to-date contact information at the time of entry.

Employees of TRTA and their immediate family members are not eligible to participate.

Giveaway Period

The Giveaway begins at **12:01 a.m. Central Time on August 10, 2026**, and ends at **2:30 p.m. Central Time on August 31, 2026** (“Giveaway Period”).

All entries must be submitted during the Giveaway Period to be eligible.

How to Enter

To enter, eligible TRTA members must complete and submit the official **TRTA Not Back to School Giveaway form** during the Giveaway Period.

Each eligible member is limited to **one (1) entry**. No purchase or payment is necessary to enter.

Entries that are incomplete, illegible, late, or otherwise do not comply with these Official Rules may be disqualified.

Prize

Five (5) winners will each receive **one (1) \$100 Amazon gift card**, for a total of five (5) prizes with an aggregate value of \$500.

The prize is non-transferable and may not be redeemed for cash, except where required by law. TRTA is not responsible for lost, stolen, or misused gift cards after delivery to the winner.

Winner Selection

Five (5) winners will be selected in a random drawing conducted by TRTA on or about **August 31, 2026**, from all eligible entries received during the Giveaway Period.

The odds of winning depend on the total number of eligible entries received.

TRTA's decisions regarding the Giveaway and the selection of winners are final and binding.

Winner Notification

Winners will be contacted using the contact information provided on the Giveaway form.

If a selected winner:

- Cannot be contacted;
- Fails to respond within **two (2) calendar days** after TRTA's initial attempt to notify the winner;
- Is determined to be ineligible; or
- Declines the prize,

TRTA reserves the right to select an alternate winner from the remaining eligible entries.

General Conditions

TRTA reserves the right to cancel, suspend, or modify the Giveaway, in whole or in part, if fraud, technical failures, or any other factor beyond TRTA's reasonable control impairs the integrity or proper functioning of the Giveaway.

TRTA reserves the right to disqualify any individual who tampers with the entry process, provides false or misleading information, attempts to participate through fraudulent means, or otherwise violates these Official Rules.

Limitation of Liability

By participating in the Giveaway, entrants agree to release and hold harmless TRTA, its officers, directors, employees, volunteers, and their respective affiliates from any and all liability arising out of or relating to participation in the Giveaway or the acceptance, possession, or use of any prize, except where prohibited by law.

Privacy

Information collected through the Giveaway form will be used in accordance with TRTA's Privacy Policy and for purposes of administering the Giveaway.

Governing Law

The Giveaway is governed by the laws of the State of Texas, without regard to its conflict of law principles.
